Subject: Update of Southern California Gas Company Service Area Maps

Southern California Gas Company (SoCalGas) hereby submits for filing revisions to its tariff schedules, applicable throughout its service territory, as shown on Attachment B.

<u>Purpose</u>

The purpose of this clean-up filing is to re-file SoCalGas' service area maps which have been digitized so that they can be posted in SoCalGas' website.

Information

SoCalGas is filing herein all the maps except those impacting Pacific Gas & Electric Company's (PG&E) territory in Kern County. The Kern County maps will be filed later under a separate Advice Letter.¹

These digitized maps are the same as those that are now currently filed with the California Public Utilities Commission (Commission) except for cosmetic changes. SoCalGas also is re-filing the tariff sheets containing the legal description delineating the boundaries for its service area. The tariff sheets containing the legal description are now electronic and have been re-typed with no substantial changes. In addition, the legal description for the territorial boundary lines between SoCalGas and Southwest Gas Corporation by Los Angeles and San Bernardino County Border has been re-typed as a new tariff sheet. It was originally included only in the body of Advice No. 1949-A filed on July 30, 1990, but not as a tariff sheet. The only other minor change made is the reference to the City of Long Beach Municipal Gas Department now called Long Beach Energy.

The Zone Rate Credit Eligibility Boundary Map that is still showing as current and effective is hereby deleted. The approval of Advice No. 2410 eliminated the Zone Rate Credit and therefore the map is unnecessary.²

¹PG&E and SoCalGas are in consultation with each other, but have not ironed out all the issues.

²Advice No. 2410 became effective on May 1, 1995.

This filing will not increase or decrease any rate or charge, conflict with any schedules or rules, or cause the withdrawal of service.

Protest

Anyone may protest this Advice Letter to the Commission. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be submitted expeditiously. The protest must be made in writing and must be received within 20 days of the date this Advice Letter. There is no restriction on who may file a protest. 

TERRITORIAL BOUNDARY LINES BETWEEN SOUTHERN CALIFORNIA GAS COMPANY AND LONG BEACH ENERGY

GENERAL STATEMENT

The following descriptions delineate the boundary between contiguous service areas of Southern California Gas Company and Long Beach Energy in Los Angeles County. These descriptions shall apply wherever reference is made in the Description of Rate Areas to the service or operating line or territorial boundary of the Company.

The description of the boundary separating the operating territories of Southern California Gas Company and Long Beach Energy is divided, for reference purposes, into four sections: "A" through "D". The general area included in each section is indicated on the Boundary Index Map.

Where the territorial boundary is located on a street property line, both sides of the street will be served either by the Company or Long Beach Energy in whose territory the street lies. Where the boundary line is located on the street centerline, the Company or the Long Beach Energy will serve its side of the boundary.

BOUNDARY DESCRIPTION

Section "A"

The boundary described in this section extends generally northerly from the Pacific Ocean at the western boundary of Orange County to the intersection of the centerline of Coyote Creek and the easterly prolongation of the south P/L of Tract No. 24709. The area <u>east</u> of this line is served by <u>Southern</u> <u>California Gas Company</u> and the area <u>west</u> of this line is served by <u>Long Beach Energy</u>.

Beginning at the point of intersection of the eastern terminus of the Long Beach breakwater in the Long Beach Outer Harbor and the western boundary line of Orange County; thence northeasterly along the boundary line of Orange County to a point in said boundary line common with the boundary line of the City of Long Beach (as of January 1, 1960); thence northwesterly, northerly, easterly and northerly along the various courses of said boundary line of the City of Long Beach to its intersection with the easterly prolongation of the south P/L of Anaheim Road; thence westerly along said prolongation to the C/L of San Gabriel River (Los Angeles County Flood Control Channel); thence northeasterly along said C/L to the C/L of Coyote Creek (Los Angeles County Flood Control Channel); thence continuing northeasterly along the C/L of Coyote Creek to its intersection with the easterly prolongation of the south P/L of Angeles County Flood Control Channel); thence continuing northeasterly along the C/L of Coyote Creek to its intersection with the easterly prolongation of the south P/L of Tract No. 24709, dated August 4, 1960, as recorded in Book 660, page 2 of the Los Angeles County Map Records.

BOUNDARY DESCRIPTION (Continued)

Section "B"

The boundary described in this section extends generally westerly and northerly from the intersection of the centerline of Coyote Creek and the easterly prolongation of the south P/L of Tract No. 24709 to the intersection of the centerline of Downey Avenue and the centerline of 70th Street. Generally, the area <u>north</u> and <u>east</u> of this line is served by <u>Southern California Gas Company</u> and the area <u>south</u> and <u>west</u> of this line is served by <u>Long Beach Energy</u>.

Beginning at the intersection of the C/L of Coyote Creek and the easterly prolongation of the south P/L of Tract No. 24709, dated August 4, 1960, as recorded in Book 660, page 2, of the Los Angeles County Map Records; thence westerly along the said prolongation and continuing westerly along the south P/L of Tract 24709, located south of Timor Street, to the C/L of Norwalk Boulevard; thence northerly along the C/L of Norwalk Boulevard to the northern boundary of the City of Long Beach as set forth in the City of Long Beach Annexation Increment No. 155, dated 7-5-60, which is also the boundary between Rancho Los Alamitos and Rancho Los Coyotes; thence northwesterly along said boundary, which is northeasterly of and parallel to Ring Street, to the C/L of the San Gabriel River Freeway; thence northwesterly along the C/L of Carson Street; thence westerly along the C/L of Carson Street to the C/L of Bellflower Boulevard.

Thence northerly along the C/L of Bellflower Boulevard to the C/L of Del Amo Boulevard; thence westerly along the C/L of Del Amo Boulevard to the CL of Lakewood Boulevard; thence southerly along the C/L of Lakewood Boulevard to the C/L of Carson Street; thence westerly along the C/L of Carson Street to the common boundary between the City of Lakewood and the City of Long Bach, as it existed April 16, 1954, which is approximately $652.09 \pm$ feet west of the westerly P/L of Lakewood Drive.

Thence southwesterly and westerly along said common boundary between the Cities of Lakewood and Long Beach to the easterly P/L of the Union Pacific Railroad right of way; thence southerly along said common City boundary to a point 370 feet north of the north P/L of Wardlow Road; thence westerly along the boundary of the City of Lakewood, as of April 16, 1954, to the boundary of the City of Long Beach at the easterly P/L of Cherry Avenue.







GENERAL STATEMENT

The following descriptions delineate the boundary established between contiguous service areas of Southern California Gas Company (Southern) and Pacific Gas and Electric Company (Pacific) in Fresno and Kings Counties in accordance with the "Agreement Delineating Boundary Lines of Gas Service Territories of Southern California Gas Company ('Southern') and Pacific Gas and Electric Company ('Pacific') in Fresno and Kings Counties," dated December 3, 1958 on file with the California Public Utilities Commission. These descriptions shall apply wherever reference is made in the Description of Rate Areas to the operating boundary line or territorial boundary of the Company.

The description of the boundary separating the gas service territories of Southern and Pacific is divided for reference purposes into two Sections, "A" and "B", the latter being divided further into Subsections "B-1", "B-2" and "B-3". The location and extent of each boundary section is indicated on the Boundary Index Map.

BOUNDARY DESCRIPTION

Section "A"

The boundary in this section extends generally westerly from the west line of Range 25E, T-13S and 14S, M.D.B.&M. to the center line of the Fresno Slough in T-15S, R-17E, M.D.B.&M. Generally, the area to the <u>north</u> of this boundary is served by <u>Pacific</u> and the area to the <u>south</u> is served by <u>Southern</u>. The boundary line described herein was previously established in central Fresno County by agreement dated January 4, 1956, between the two companies, and authorized by Resolutions G-1026 and G-1027 of the California Public Utilities Commission under Advice Nos. 429 and 279 filed by Southern and Pacific, respectively.
