# Subject: Additional Hazardous Substance Site

Southern California Gas Company (SoCalGas) hereby requests the California Public Utilities Commission (Commission) approval to include Goleta Gas Storage Field (Site) in the Hazardous Substance Cost Recovery Account (HSCRA) as referenced within SoCalGas' Preliminary Statement Part V.C, in compliance with Decision (D.)94-05-020.

# **Background**

D.94-05-020 requires California utilities to file an advice letter in order to include additional sites as part of the Hazardous Substance Mechanism. For each site the advice letter shall list: 1) the name of the site; 2) the location of the site; 3) the source, nature and approximate date of the contamination; 4) utility operations (historical and current) at the site, if any; and 5) environmental agency and oversight regarding the site, if any.

In addition, D.96-07-016 requires utilities to demonstrate that: 1) clean-up costs for which recovery is being sought are not being recovered through base rates or through any other recovery procedure; and 2) all of the costs for which recovery is being sought are hazardous waste clean-up costs (including insurance costs) found appropriate for recovery in the Collaborative Report.

SoCalGas owns and operates the Goleta Natural Gas Storage Field.

## **Required Information**

The relevant information for the Goleta Gas Storage Field Site is as follows:

Site Name: Goleta Storage Field

Location: 1171 More Ranch Road, Goleta, California

# Utility Operations (Historical and Current) at the Site

The Site has been used for natural gas field operations and gas storage since 1921. Pacific Lighting Corp. (predecessor to SoCalGas) acquired the field and began using it for gas storage in 1941. The Goleta Gas Storage field is solely owned and operated by SoCalGas, a public utility and subsidiary of Sempra Energy, with the company regional headquarters located in downtown Los Angeles, California. The storage field includes several gas injection and withdrawal wells, a natural gas compressor station, a dehydration unit, ancillary units, and a large underground natural gas storage reservoir, where natural gas is injected and stored during periods of low demand. During heavy demand periods, the gas is withdrawn from the reservoir, dehydrated, odorized, and then routed to pipelines within SoCalGas' service territory.

## Source, Nature, and Approximate Date of Contamination

Contaminated soil was discovered in the southeastern portion of MU#9 in March 2004. Both soil and groundwater were sampled and analyzed and found to be impacted with volatile organic compounds (VOCs). In addition, release from a condensate line was discovered in January 1991 and was investigated between 1991 and 1995. Soil and groundwater sampling indicated the presence of VOCs.

## Nature of Costs

The environmental site investigation and potential cleanup costs that SoCalGas is seeking to recover through the procedure are not being recovered through base rates or through any other recovery procedure. All investigation and potential cleanup costs included by SoCalGas in the procedure will be hazardous waste cleanup costs found appropriate for recovery in the Hazardous Substance Cleanup Cost Recovery Collaborative Report, dated November 19, 1993. SoCalGas anticipates recording investigation costs related to the Goleta Storage Field site in its HSCRA beginning in November 2007 and cleanup costs, if necessary, beginning in the third quarter of 2008.

## **Protest**

Anyone may protest this Advice Letter to the Commission. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be submitted expeditiously. The protest must be made in writing and must be received within 20 days of the date this Advice Letter. There is no restriction on who may file a protest.
