**Subject:** Publication of Open Season Results for Line 7000 in the San Joaquin Valley, and Update regarding the Imperial Valley System Expansion

Southern California Gas Company ("SoCalGas") hereby submits for filing with the California Public Utilities Commission ("Commission") this publication of the results of the Open Season held for firm service contracts commencing April 1, 2009 for Line 7000 in the San Joaquin Valley. Additionally, SoCalGas is updating the Commission on the expansion of the Imperial Valley System (Line 6902) by installing Line 6914.

#### **Background**

SoCalGas has identified the Imperial Valley and San Joaquin Valley as potentially constrained areas since 2001. SoCalGas conducted Open Seasons in both areas in 2003, 2005, and 2007. The 2009 San Joaquin Valley Open Season was held for firm service contracts commencing on April 1, 2009 with use-or-pay obligations. In Imperial Valley, based on the 2007 open season results and an analysis of likely future demand, SoCalGas determined that an expansion was necessary. Pursuant to AL 3747, the Imperial Valley System was expanded to relieve the constraint. Therefore, an open season was not held in the Imperial Valley, and firm full service contracts were offered to all noncore eligible customers.

#### San Joaquin Valley Open Season Results

SoCalGas sent bid packages to one hundred twenty-six (126) customers currently noncore, noncore eligible, or expected to be noncore eligible within the term of this Open Season. Forty-one (41) customers bid for firm noncore service, thirty-two (32) elected core service, fifty-one (51) elected interruptible noncore, and one (1) account closed. Two of the firm customers were large customers and therefore were required to bid a five-year term. SoCalGas was able to award all customer bids for firm noncore service. There were six (6) customers that switched from firm to interruptible, and four (4) customers that switched from interruptible to core within the San Joaquin Valley potentially constrained area.

The existing infrastructure is adequate to supply all core and firm noncore requirements and no expansions are planned at this time. Based on these results, and in accordance with

Special Condition 36 of Schedule No. GT-F, Firm Intrastate Transmission Service, if the Commission agrees that no expansion is needed; SoCalGas will reduce the commitment for the San Joaquin Valley large customers from five years to two years, consistent with the term for small customers. Schedule No. GT-F Special Condition 36 states in part as follows:

36. Term: "...In the event all requests for firm noncore capacity can be awarded without proration and the Utility does not plan to expand the local transmission system within the five-year contract period, the Utility will inform the Commission. Upon Commission agreement that there is no need to construct additional facilities within the five-year contract period, the Utility shall amend the five-year contracts to expire after two-years, consistent with the term for small customers."

Current capacity in the San Joaquin Valley is 180 MMcfd. Peak firm demand (core 1-in-10 year cold day demand plus noncore firm bids) is 146 MMcfd, leaving excess capacity of at least 34 MMcfd through 2011. Based on these results and SoCalGas' analysis of likely firm demand, SoCalGas has determined that no additional facilities are needed at this time.

Upon Commission agreement that there is no need to construct additional facilities within the five-year contract period, SoCalGas shall amend the term of the five-year contracts for large customers to expire after two years, consistent with the term for small customers and in compliance with Special Condition 36 of Schedule No. GT-F.

## **Imperial Valley System Expansion**

Due to the Imperial Valley system expansion, an open season for firm service was not offered. Seven (7) noncore eligible customers were offered firm transportation service. Of those seven, three are core, two are noncore interruptible, and two are noncore firm. There is one customer with a long term transportation contract, and one large customer that was prorated in the 2007 open season with a five (5) year term. The prorated customer will be awarded their full bid amount per Special Condition 45 of Schedule No. GT-F, and the term will be adjusted to two (2) years beyond the in-service date of the system expansion per Special Condition 36. Schedule No. GT-F Special Conditions 36 and 45 state in part as follows:

- <u>36. Term:</u> "...For large noncore customers, the term for firm service shall be the earlier of (a) two (2) years beyond the in-service date of facilities associated with the expansion of local transmission service, or the commencement of service on interstate and/or foreign pipelines or other arrangements that alleviate the need for expanding local transmission facilities, limited to the contractual commitments approved in D.07-05-022; or (b) five (5) years. For small noncore customers, the term is two years."
- 45. Awarding of Firm Noncore Capacity: "...After, and to the extent, the Utility places into service facilities that can provide higher levels of firm service, all customers' awards will be increased by a pro-rated amount, up to their bid amounts, for the duration of their contracts. During the term of its contract, a large customer may not change its bids for firm service for any of the time periods in the Addendum..."

Per AL 3747, in order to meet an expected increase in firm demand, SoCalGas installed Line 6914, which consists of 22 miles of 24-inch diameter pipe to loop the Imperial Valley transmission system north from El Centro towards Niland. This expansion increased the capacity of the Imperial Valley transmission system by 114 MMcfd, from 86 MMcfd to 200 MMcfd.

#### **Protest**

Anyone may protest this Advice Letter to the Commission. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be submitted expeditiously. The protest must be made in writing and must be received within 20 days of the date of this Advice Letter. There is no restriction on who may file a protest.
