<u>Subject</u>: CARE Transportation Surcharge for Recovery of Well Work Project Costs Updated for 2010

Southern California Gas Company (SoCalGas) hereby submits for filing revisions to its tariff schedules, applicable throughout its service territory, as shown on Attachment B, to be effective on January 1, 2010.

Purpose

This filing updates the CARE Transportation Surcharge for 2010 consistent with Ordering Paragraph (OP) 3 of Decision No. (D.) 05-11-027, dated November 18, 2005, and Advice No. (AL) 3561, dated December 10, 2005 and approved January 7, 2006, which established the necessary procedures for allocating to SoCalGas' California Alternate Rates for Energy (CARE) procurement customers the well work costs associated with maintaining the deliverability capability at the Aliso and Goleta storage fields as a result of releasing the cushion gas to CARE customers pursuant to D.05-11-027.

Background

To provide low-income customers greater winter bill protection, the Commission issued D.05-11-027 approving SoCalGas' request to transfer 4 BCF of storage cushion gas in-kind at book cost to CARE procurement customers to help mitigate the impact of high natural gas prices over the four-month period of December 2005 through March 2006. Pursuant to the decision, 4 BCF of gas would be transferred to the core portfolio and the avoided cost benefits allocated solely to CARE procurement customers. Additionally, in compliance with OP 3 of D.05-11-027, SoCalGas filed AL 3561 for approval of SoCalGas' proposed procedures for allocating the capital project costs associated with maintaining the deliverability capability at the Aliso and Goleta storage fields as a result of releasing the cushion gas to SoCalGas' CARE procurement customers.¹

¹ In SoCalGas' General Rate Case (GRC) D. 08-07-046, the cost of the project was reflected in authorized ratebase. Therefore, the base margin revenue requirements adopted in the GRC will be reduced by the annual authorized surcharge revenues that will be collected from CARE customers in determining transportation rates charged to customers.

A Petition for Modification of D.05-11-027 was filed by SoCalGas on January 12, 2006 and was granted by D.06-02-034, dated February 16, 2006. As a consequence of D.06-02-034, SoCalGas filed AL3602 on February 28, 2006 which revised SoCalGas' income-qualified rate schedules to extend the benefits from the cushion gas in order to keep the CARE commodity rate in any winter month from exceeding 80¢ per therm through March 31, 2008.

CARE Transportation Surcharge Update

Based on procedure 3 adopted in AL 3561, SoCalGas was to establish a surcharge as follows:

"Over the useful life of the asset, a surcharge will be developed to recover from CARE customers the revenue requirements associated with the undepreciated book cost of the capital project costs. SoCalGas will file an advice letter to revise rates after the completion of the project, and the surcharge will be implemented after receiving Commission approval. It is anticipated that the project will be completed in the first quarter of 2006. The surcharge will be charged to CARE customers over the recovery period subject to further Commission review of the cost allocation in the next phase of this proceeding or in a subsequent BCAP."

SoCalGas plans to recover the 2010 revenue requirement over 12 months in the surcharge rate established beginning January 1, 2010. The base margin revenue requirement related to the capital project for Year 2010 is approximately \$2.421 million, a decrease of \$0.248 million compared to the 2009 revenue requirement used to establish the 2009 surcharge rate².

SoCalGas shall establish a surcharge rate to ensure that only CARE customers pay for the revenue requirement associated with the capital project. Based on the 2010 revenue requirement described above, the surcharge rate is 0.399 cents/therm, a 0.138 cents/therm (25.8 %) decrease compared to the 0.537 cents/therm surcharge rate established in 2009³.

Revision to Income-Qualified Rate Schedules

The current income-qualified tariffs which reflect an additional transportation surcharge to CARE procurement customers as described above is herein revised (see Attachment B)⁴. The resultant CARE procurement customer's transportation rates shown are for exemplary purposes and will be updated with actual rates effective on January 1, 2010.

The Transmission Charges for CARE-eligible procurement customers shown below include an additional charge of 0.399 cents per therm to recover the well work costs associated with maintaining the deliverability capability at the Aliso and Goleta storage fields as a result of releasing the cushion gas to CARE procurement customers pursuant to D.05-11-027.

January 1, 2010 Rates

The surcharge rate will be consolidated with other Commission-authorized changes in SoCalGas' revenue requirement and rates that will be filed by advice letter at least three days prior to January 1, 2010, the effective date of such rates.

³ Upon approval of SoCalGas' BCAP (Application 08-02-001) and implementation of BCAP rates, the CARE transportation surcharge rate will be eliminated as proposed in the testimony of SoCalGas witness Gary Lenart.

The surcharge is not applicable to CARE transportation-only service including Core Aggregation Transportation (CAT) as these customers did not receive any avoided cost benefits associated with the cushion gas.

Protest

Anyone may protest this Advice Letter to the Commission. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be submitted expeditiously. The protest must be made in writing and received within 20 days of the date of this Advice Letter. There is no restriction on who may file a protest.
