<u>Subject</u>: Schedule No. GT-SWGX - Exchange Wholesale Natural Gas Service – Exchange Rate

Public Utilities Commission of the State of California

Southern California Gas Company (SoCalGas) hereby submits for filing with the California Public Utilities Commission (Commission) revisions to its Schedule No. GT-SWGX (GT-SWGX), Exchange Wholesale Natural Gas Service applicable to Southwest Gas Corporation (Southwest), as shown on Attachment B.

## **Purpose**

This filing revises the rate (Exchange Rate) SoCalGas charges Southwest for exchange transportation service pursuant to GT-SWGX. The Exchange Rate recovers certain exchange fees charged by Pacific Gas and Electric Company (PG&E) to SoCalGas plus SoCalGas' system balancing costs, and applies only to gas quantities delivered to Southwest through delivery points served by PG&E.

#### **Background**

In Decision (D.) 09-10-036 the Commission adopted an exchange contract between SoCalGas and PG&E and a transportation contract between SoCalGas and Southwest. These contracts govern SoCalGas' service to, and rates for, Southwest. Pursuant to that decision, the PG&E exchange fee shall automatically change if the Commission approves modification to any of the tariffed components of the formula used to determine the exchange fee. When the PG&E exchange fee changes, the Exchange Rate between SoCalGas and Southwest also will change as stated in GT-SWGX and in the transportation contract between SoCalGas and Southwest. On August 15, 2011, the Commission approved PG&E's Advice 3200-G. This advice filing changed PG&E's transportation rates, which in turn resulted in a new exchange fee charged by PG&E to SoCalGas.

## **Requested Revision**

This filing increases the Exchange Rate in GT-SWGX from 4.136 ¢/therm to 4.266 ¢/therm, which is the sum of the newly calculated PG&E exchange fee of 4.139 ¢/therm and the unchanged SoCalGas system balancing cost adder of 0.127 ¢/therm. Pursuant to the contract between PG&E and SoCalGas adopted in D.09-10-036, the new PG&E exchange fee will be charged to SoCalGas on the first day of the 2<sup>nd</sup> month following Commission approval of the underlying tariff changes.<sup>3</sup> Since the tariff changes were approved on August 15, 2011, the new exchange fee will become effective on October 1, 2011. Pursuant to the contract between SoCalGas and Southwest adopted in D.09-10-036, the revised Exchange Rate charged by SoCalGas to Southwest becomes effective on the same date.<sup>4</sup>

#### **Protest**

Anyone may protest this Advice Letter to the Commission. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be submitted expeditiously. The protest must be made in writing and must be received within 20 days of the date of this Advice Letter, which is September 20, 2011. There is no restriction on who may file a protest. ## **APPLICABILITY**

## **TERRITORY**

Delivery points shall be as specified in the executed Master Services Contract, Schedule A, Intrastate Transmission Service, dated December 10, 2008 ("Contract").

## **RATES**

#### **Exchange Fee Charges**

As specified in the Contract, the Exchange Rate recovers certain exchange fees charged by PG&E to Utility plus Utility's system balancing costs, and applies only to gas quantities delivered through Points of Delivery served by PG&E. Pursuant to the Contract, the Exchange Rate shall automatically change if the Commission approves modification to any of the tariffed components of the formula used to determine the exchange fee.

## Pisgah Meter Station Charges

As specified in the Contract, Pisgah Meter Station Charges are monthly charges associated with the Pisgah Meter Station Upgrade.

## **Billing Adjustments**

Billing adjustments may be necessary to reflect changes in quantities used in developing prior periods' exchange charges.

Rates may be adjusted to reflect any applicable taxes, franchise or other fees, regulatory surcharges, and interstate or intrastate pipeline charges that may occur.
