Subject: Revisions to the In-Kind Energy Charge in Schedule Nos. G-BSS, G-LTS, and G-TBS Pursuant to Decision (D.) 09-11-006

Southern California Gas Company (SoCalGas) hereby submits revisions to its tariff Schedule Nos. G-BSS (Basic Storage Service), G-LTS (Long-Term Storage Service), and G-TBS (Transaction Based Storage Service) as shown on Attachment A.

<u>Purpose</u>

This compliance filing seeks approval of the California Public Utilities Commission (Commission) to revise Schedule Nos. G-BSS, G-LTS, and G-TBS to decrease the In-Kind Energy Charge from 2.40% to 2.33%, effective April 1, 2015.

Background

In D.09-11-006, the Commission approved San Diego Gas & Electric Company's and SoCalGas' 2009 Biennial Cost Allocation Proceeding (BCAP) Phase Two Settlement Agreement (SA). Section II.B.2.G (page 10) of the SA states, "...The initial injection fuel rate shall be set at 2.4% for the first full storage year under this settlement commencing on April 1, 2010, and shall be adjusted for each subsequent storage year under this settlement on the basis of a three-year rolling average." The term "initial injection fuel rate," used in the SA, is synonymous with the term "In-Kind Energy Charge," which has been used in Schedule Nos. G-BSS, G-LTS, and G-TBS.

On December 8, 2009, SoCalGas filed revisions to its tariffs (including Schedule Nos. G-BSS, G-LTS, and G-TBS) with Advice No. (AL) 4047 to comply with Ordering Paragraph 4 of D.09-11-006 to implement and carry out the terms and conditions of the

SA and to present the necessary tariff revisions. The revisions to Schedule Nos. G-BSS, G-LTS, and G-TBS, which also reflected the initial In-Kind Energy Charge of 2.40%, were approved by the Energy Division on January 19, 2010 and made effective April 1, 2010 for the 2010 storage year (April 1, 2010 through March 31, 2011). AL 4205, AL 4330 and AL 4454 used the same Commission-approved methodology of three-year rolling average for the calculation of In-Kind Energy Charges for the 2011, 2012 and 2013 storage years, respectively. AL 4205, AL 4330 and AL 4454 were approved by the Commission on March 17, 2011, March 15, 2012 and March 6, 2013, respectively.

SoCalGas has determined that, on the basis of three-year rolling average, the In-Kind Energy Charge for the 2015 storage year (April 1, 2015 through March 31, 2016) should be **2.33**%. The back-up calculations for the In-Kind Energy Charge for the 2015 storage year are shown on Attachment B. SoCalGas believes that the tariff revisions shown on Attachment A are necessary to implement the Commission's decision.

Protest

Anyone may protest this advice letter to the Commission. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be submitted expeditiously. The protest must be made in writing and received within 20 days of the date this advice letter was filed with the Commission, which is February 19, 2015. Effective Date

SoCalGas believes that this filing is subject to Energy Division disposition, and should be classified as Tier 2 (effective after staff approval) pursuant to GO 96-B. This filing is consistent with D.09-11-006 and therefore SoCalGas respectfully requests that this filing be approved on March 1, 2015, which is thirty (30) calendar days after the date filed, but made effective April 1, 2015 (see the Background section above).

If this filing is not approved by Friday, March 27, 2015, SoCalGas respectfully requests the revised tariffs be made effective at least two days after verbal or electronic notification of the approval is communicated to SoCalGas. The requested minimum two-day time lag between the approval date and the effective date is based on the time that is needed to reflect the new In-Kind Energy Charge in Envoy and allow shippers/customers to adjust their gas deliveries and meet nomination deadlines.

- 4. As a condition precedent to service under this schedule, an executed Master Services Contract, Schedule F, Long-Term Storage Service (Form Nos. 6597 and 6597-6) is required. All contracts, rates and conditions are subject to revision and modification as a result of Commission order.
- 5. The minimum contract term for service under this schedule shall be three years and the maximum contract term shall be fifteen years.
- 6. The storage year for long-term contract service shall begin on April 1 and continue thereafter for a twelve month period. Eligible customers may contract for long-term storage service anytime during this period but the annual reservation charges applicable for the initial storage year shall not be prorated unless otherwise agreed to by the Utility.

- 2. Service under this schedule shall be curtailed in accordance with the provisions of Rule No. 23.
- 3. All terms and conditions of Rule No. 30 and Schedule No. G-IMB shall apply to the transportation of customer-owned gas in conjunction with the storage services provided under this schedule.
- 4. As a condition precedent to service under this schedule, an executed Master Services Contract (Form No. 6597) and an executed Master Services Contract, Schedule I, Transaction Based Storage Service (Form No. 6597-11) are required (referred to in this schedule collectively as the "Contract"). All contracts, rates and conditions are subject to revision and modification as a result of Commission order.
- 5. The contract term for service under this schedule shall be set forth in the customer's Contract.
- 6. Any quantity of storage gas that is in excess of the inventory rights remaining after: a) the customer's storage Contract term expires; or b) the customer trades away some or all of its inventory rights; or c) the customer's storage Contract is terminated, for whatever reason, prior to the completion of the term of such Contract shall be immediately purchased by the Utility at the applicable Buy-Back Rate stated in Schedule No. G-IMB. The Buy-Back purchase amount paid to the customer may be reduced by any outstanding amounts owed by the customer for any other services provided by the Utility.
