# Subject: Supplement: Partial Firm Curtailment Advice Letter filed on March 25, 2015

### <u>Purpose</u>

Southern California Gas Company (SoCalGas) hereby submits this advice letter to notify the California Public Utilities Commission (Commission) and affected parties of a curtailment event in its service territory.<sup>1</sup> This filing replaces in its entirety Advice No. (AL) 4782, filed on March 25, 2015.

#### **Background**

SoCalGas' Rule No. 30, Transportation of Customer-Owned Gas, provides that the Utility may interrupt the gas transmission service for the purpose of testing, altering, enlarging or repairing its facility or property comprising of its system as long as priority of service is in accordance with provisions of Rule No. 23, Continuity of Service and Interruption of Delivery. SoCalGas' Rule No. 23(G) provides as follows:

The Utility, whenever it finds necessary for the purpose of making repairs or improvements to its system, will have the right to suspend temporarily the delivery of gas, but, in all such cases, as reasonable notice thereof as circumstances will permit will be given to customers, and the making of such repairs or improvements will be prosecuted as rapidly as may be practicable, and, if practicable, at such times as will cause the least inconvenience to the customers.

SoCalGas initially filed AL 4782 with March 17, 2015 erroneously listed as the date the localized partial curtailment was initiated. The localized curtailment in question actually

began on March 7, not March 17. This supplement changes the curtailment start date to correct that error. In all other respects AL 4782-A is the same as AL 4782.

#### **Information**

SoCalGas initiated a localized partial firm curtailment of noncore customers on March 7, 2015 which is expected to be completed on March 31, 2015 in order to complete both Pipeline Safety Enhancement Plan and Pipeline Integrity work.<sup>2</sup> Firm gas service will be available on a reduced basis and supply pipeline pressures are expected to be lower than normal during the time of the scheduled work.

This localized curtailment affects the city of Oxnard area bordered on the north of W. 5th Street, on the south of W. Gonzales Road, on the west of N. Harbor Blvd., and on the east of the coastline.<sup>3</sup> Just two customers are affected by this partial firm noncore curtailment. SoCalGas provided advance notification to both customers of the pipeline maintenance and planned curtailment prior to March 7, 2015, and SoCalGas has been working with both customers to help meet their service needs since the beginning of the curtailment. A subsequent notice was posted on Envoy on March 25, 2015.<sup>4</sup>

#### Protest

Anyone may protest this Advice Letter to the Commission. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be submitted expeditiously. The protest must be made in writing and received within 20 days of the date of this Advice Letter which is April 19, 2015. There is no restriction on who may file a protest. This was not done in the present case because of initial confusion at SoCalGas regarding the applicability of this requirement to a maintenance-related service interruption only affecting two customers. This was a mistake, and SoCalGas apologizes for any inconvenience this notification delay may have created.
