Subject: Request for Approval of a Natural Gas Administrative Services Agreement between Southern California Gas Company and Gasoducto Rosarito

Purpose

Southern California Gas Company (SoCalGas) hereby submits for approval by the California Public Utilities Commission (Commission) a new proposed Natural Gas Administrative Services Agreement (Agreement) SoCalGas entered into with its Mexican affiliate, Gasoducto Rosarito (GR).

Information

On February 16, 2015, SoCalGas entered into the Agreement with GR which provides necessary administrative support (fees, taxes and other third party charges) whenever SoCalGas transports natural gas on the pipelines of its Mexican affiliates, GR and Transportadora de Gas Natural. The Agreement and related interruptible transportation agreements enable SoCalGas to transport gas from the Ehrenberg/Blythe system receipt point to Otay Mesa, and are used to provide support for SoCalGas' Southern System and also to test pipelines for system integrity.¹ The Agreement will not become effective unless and until approved by the Commission.

¹ The interruptible transportation contracts are the subject of pending Advice No. (AL) 4668 submitted on July 8, 2014. AL 4668 has been suspended pending Commission review.

The Agreement is confidential and being provided only to the Energy Division under the provisions of General Order 66-C and Section 583 of the Public Utilities Code as Attachment A.

This filing will not increase or decrease any rate or charge, conflict with any schedules or rules, or cause the withdrawal of service.

Protest

Anyone may protest this Advice Letter to the Commission. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be submitted expeditiously. The protest must be made in writing and must be received within 20 days of the date this Advice Letter, which is April 15, 2015. There is no restriction on who may file a protest.
