Subject: Establishment of Assembly Bill 802 Memorandum Account (AB802MA)

Southern California Gas Company (SoCalGas) hereby requests California Public Utilities Commission (Commission) approval of modifications to its Preliminary Statement, Part VI, Memorandum Accounts, applicable throughout its service territory, as shown on Attachment A.

Purpose

In compliance with Assembly Bill (AB) 802, this filing establishes SoCalGas' AB 802 Memorandum Account (AB802MA). The purpose of the AB802MA is to record incremental costs and capital-related costs (i.e., depreciation, taxes, and return) associated with implementing the requirements of AB 802 to maintain and provide energy usage data to building owners and/or their agents.

Background

AB 802 was approved by California Governor Jerry Brown and filed with the Secretary of State on October 8, 2015. Pursuant to Section 5 of AB 802¹, beginning January 1, 2017, the utilities will be required to provide aggregated energy usage data for at least the most recent 12 complete months for buildings they provide service for upon the request of the building owner and/or its agents. AB 802 also requires the California Energy Commission (CEC) to adopt reporting regulations of energy data usage for the purpose of benchmarking building energy performance using ENERGY STAR Portfolio Manager or other tools.

In addition, Section 5 of AB 802 also allows for recovery of costs related to: 1) developing and maintaining systems to fully implement AB 802 requirements; 2) maintaining and

providing energy usage data in compliance with CEC data specifications; and 3) any other subsequent reporting requirements. Section 5 of AB 802 states:

The reasonable costs of an electrical or gas corporation in delivering electrical or gas usage data pursuant to this section or other information as required under state or federal law or by an order of the commission shall be recoverable in rates evaluated and approved by the Public Utilities Commission.²

Establishment of the AB802MA

Pursuant to Section 5 of AB 802, SoCalGas herein requests to establish the AB802MA, provided in Attachment A, in order to record incremental costs related to the implementation of AB 802. The disposition of the account balance and cost recovery mechanism for the AB802MA will be addressed in SoCalGas' next General Rate Case proceeding or other applicable proceeding.

Protest

Anyone may protest this Advice Letter to the Commission. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be submitted expeditiously. The protest must be made in writing and must be received within 20 days of the date of this Advice Letter which is April 3, 2016. There is no restriction on who may file a protest. 1. Purpose

The AB802MA is an interest-bearing memorandum account that is recorded on the Utility's financial statements. The purpose of the AB802MA is to record the incremental costs associated with implementing the requirements of Assembly Bill (AB) 802 to maintain and provide energy usage data to building owners and/or their agents.

2. Applicability

The AB802MA shall apply to gas customers except for those specifically excluded by the Commission.

3. <u>Rates</u>

See Disposition section below.

4. Accounting Procedures

SoCalGas maintains the AB802MA by making monthly entries, net of applicable FF&U, as follows:

- a) A debit entry to record actual incremental costs and capital-related costs (i.e., depreciation, taxes, return) associated with AB 802 compliance,
- b) An entry equal to the amortization of the account balance as authorized by the Commission, and
- c) An entry equal to interest on the average of the balance in the account during the month, calculated in the manner described in Preliminary Statement, Part I, J.
- 5. Disposition

The disposition of this account will be addressed in SoCalGas' next General Rate Case proceeding or other applicable proceeding. Upon Commission approval, SoCalGas will amortize the AB802MA balance in rates.
