Subject: Localized Firm Curtailment on August 5, 2016

Purpose

Southern California Gas Company (SoCalGas) hereby submits this Advice Letter to notify the California Public Utilities Commission (Commission) and affected parties of a curtailment event in its service territory.¹

Information

A. Facts Underlying and Reasons for the Curtailment

SoCalGas initiated a localized firm curtailment on noncore customers beginning at 6:00 p.m. on Friday, August 5, 2016 through 6:00 p.m. on Sunday, August 7, 2016 or until work is completed in order to complete Pipeline Safety & Enhancement Work. Affected firm customers will not have gas service available during the curtailment.

SoCalGas' affected customers are located in the city of Long Beach area, south of South Street, west of Lakewood Boulevard, north of Del Amo Boulevard, and east of Cherry Avenue. Refer to the map provided in Attachment A showing the general affected area.

B. Compliance with SoCalGas' Tariffs

This curtailment was instituted in accordance with Section E.2 of Rule No. 30, Transportation of Customer-Owned Gas, and Section C.1 of Rule No. 23, Continuity of Service and Interruption of Delivery.

C. Efforts by SoCalGas to Minimize or Alleviate the Curtailment

SoCalGas provided advance notification to affected customers of the pipeline maintenance and planned curtailment through their Account Managers and via our Envoy electronic bulletin board. The most recent notice was posted on Envoy on August 2, 2016.²

Protest

Anyone may protest this Advice Letter to the Commission. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be submitted expeditiously. The protest must be made in writing and received within 20 days of the date of this Advice Letter, which is August 25, 2016. There is no restriction on who may file a protest.
