<u>Subject</u>: Establishment of the Safety Culture Investigation Assessment Memorandum Account (SCIAMA), Pursuant to Administrative Law Judge's (ALJ) Ruling in SoCalGas' Safety Culture Order Instituting Investigation (OII), Investigation (I.) 19-06-014

Southern California Gas Company (SoCalGas) hereby submits for approval by the California Public Utilities Commission (Commission) modifications to its Preliminary Statement Part VI – Memorandum Accounts, applicable throughout its service territory, as shown on Attachment A.

<u>Purpose</u>

This submittal complies with ALJ Ruling dated July 14, 2020 to establish SoCalGas' SCIAMA.¹

Background

On June 8, 2020, SoCalGas filed a motion to establish the SCIAMA to track costs associated with the Safety Culture OII. On July 14, 2020, the Commission issued an ALJ ruling that the proposed memorandum account is approved, but the proposed scope of the memorandum account is not. The memorandum account is for only the consultant costs paid for by SoCalGas and not for the recording of all incremental costs associated with the OII. In compliance with the ALJ Ruling, Ruling 2, SoCalGas is modifying its tariff language in its SCIAMA Preliminary Statement as submitted in this advice letter herein, to record only the consultant costs paid by SoCalGas.

Establishment of the SCIAMA

Pursuant to ALJ Ruling dated July 14, 2020 in SoCalGas' Safety Culture OIR, the purpose of the SCIAMA is to record the consultant costs paid by SoCalGas for the investigation into the safety culture of SoCalGas. The disposition of the SCIAMA balance will be addressed in SoCalGas' next general rate case, at the conclusion of I.19-06-014, or as otherwise determined by the Commission.

The proposed new preliminary statement is included as Attachment A.

Protest

Anyone may protest this Advice Letter to the Commission. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be submitted expeditiously. The protest must be made in writing and must be received within 20 days of the date of this Advice Letter, which is October 13, 2020.
