<u>Subject</u>: Expedited Advice Letter Approval of Two Canadian Interstate Pipeline Capacity Contracts

<u>Purpose</u>

Southern California Gas Company (SoCalGas) respectfully requests approval by the California Public Utilities Commission (Commission) to enter into the following transportation capacity contracts: one TransCanada NOVA Gas Transmission Ltd. and one TransCanada Foothills System – BC Zone 8 contract. These contracts are used to transport natural gas supplies from Canada on behalf of the core customers of SoCalGas and San Diego Gas and Electric Company (SDG&E).

Background

Under the interstate capacity acquisition procedure approved in Decision (D.) 04-09-022, contracts for interstate capacity supported by the Public Advocates Office and The Utility Reform Network (TURN) may be submitted for approval to the Commission by an Expedited Advice Letter (EAL).¹ The Public Advocates Office has been consulted and concurs with the recommendations as described. TURN did not participate in the review process.

¹ See D.04-09-022 at 87 (Finding of Fact 11), which found SoCalGas' request to establish and implement expedited advice letter procedures for pre-approval of certain interstate pipeline and storage capacity contracts to be reasonable. See also Id. at 95 (Ordering Paragraph 2), which granted SoCalGas' request to establish capacity contract approval procedures for an initial period of five years, subject to the modifications described therein, as well as authorized SoCalGas to seek continuation or modification of these procedures by Advice Letter. SoCalGas Advice No. 5765 was approved on March 5, 2021, and extended the capacity contract approval procedures through March 31, 2024.

Description of Contract

The terms of the contracts are confidential and are described in Attachment A. This submittal will not create any deviations from SoCalGas' tariffs, cause withdrawal of service from any present customer, or impose any more or less restrictive conditions.

Confidentiality

Due to the confidential nature of the contracts, which contain market-sensitive negotiated core capacity contract terms, a Confidential Attachment A is being provided to Energy Division and the Public Advocates Office pursuant to General Order (GO) 66-D, Section 583 of the Public Utilities Code, and D. 21-09-020, and to TURN under the confidentiality provisions of a non-disclosure agreement. A declaration requesting confidential treatment is being provided to the Commission concurrently with this EAL, pursuant to D. 21-09-020.

Protest

Anyone may protest this EAL to the Commission. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be submitted expeditiously. The protest must be submitted electronically and received within 10 days of the date this EAL was submitted with the Commission, which is September 10, 2022.
