**Subject:** January 1, 2023 Consolidated Rate Update

Southern California Gas Company (SoCalGas) hereby submits for approval by the California Public Utilities Commission (Commission or CPUC) revisions to its tariff schedules, applicable throughout its service territory, as shown in Attachment A.

#### **Purpose**

This submittal consolidates SoCalGas's rate adjustments authorized by the Commission pursuant to relevant decisions and advice letters effective January 1, 2023.

#### Information

This advice letter implements the rate adjustments requested by compliance Advice No. (AL) 6045 and Decision (D.) 20-02-045, Annual Regulatory Account Balance Update; AL 6044 and D.19-09-051 and D.22-12-031, Test Year (TY) 2019 General Rate Case (GRC) Rate Attrition and Cost of Capital; AL 6018, Adjustment to Revenue Requirement in Accordance with Internal Revenue Service Private Letter Ruling; AL 6023 and D.22-08-011, Storage Integrity Management Program; AL 5853-A,On-Bill Financing Changes; AL 5907 and D.21-07-019, Triennial Cost Allocation Proceeding (TCAP) Implementation; and AL6039, Low-Carbon Fuel Standard (LCFS) Program Annual Credit and Revenue Estimates (2023).

#### <u>Annual Regulatory Account Balance Update - AL 6045</u>

Advice Letter 6045, approved on October 19, 2022, proposed implementing the annual update of regulatory account balances for amortization in 2023 rates. The advice letters complied with the longstanding practice of updating SoCalGas' revenue requirement for

projected year-end regulatory account balances, as authorized in D.20-02-045, SoCalGas' most recent Triennial Cost Allocation Proceeding (TCAP).

AL 6045 proposed a \$181.1 million increase in SoCalGas' transportation revenue requirement for core customers and a \$36.9 million increase in SoCalGas' transportation revenue requirement for noncore customers, resulting in a total increase of \$218.0 million (with Franchise Fees & Uncollectibles (FF&U)). In addition, AL 6045 proposed a decrease in the revenue requirement for Backbone Transportation Service (BTS) of \$4.4 million (with FF&U).

Moreover, AL 6045 revised SoCalGas' revenue requirement for Company-Use (CU) Fuel and Unaccounted For (UAF) Gas costs. For 2023, SoCalGas forecasted an average gas price of \$6.52/MMBtu, an increase of \$1.60/MMBtu from the \$4.92/MMBtu currently in rates, resulting in an increase in the authorized costs for CU Fuel and UAF Gas of \$15.5 million (with FF&U) compared to the present revenue requirement.

In addition, AL 6045 requested to include the 2023 Greenhouse Gas (GHG) revenue requirement, resulting in an increase of \$29.4 million (with FF&U) compared to the present revenue requirement.

AL 6045 also requested revenue requirements attributable to 2016 Pipeline Safety Enhancement Plan (PSEP) Reasonableness Review (\$10.7 million, without FF&U and prior to SoCalGas and San Diego Gas and Electric Company (SDG&E) Transmission System Integration<sup>1</sup> (System Integration)), 2017 PSEP Forecast Application (\$26.9 million without FF&U and prior to System Integration), and 2018 PSEP Reasonableness Review (\$73.7 million, without FF&U and prior to System Integration).

TY 2019 GRC Rate Attrition with Cost of Capital Adjustment - AL 6044, D.19-09-051 and D.22-12-031

Pursuant to D.19-09-051, AL 6044, and D.22-12-031, SoCalGas' 2023 revenue requirement provides a gas base margin revenue requirement of \$3,275 million with FF&U, net of miscellaneous revenue and the cost of capital adjustment. This represents an attrition year increase, adjusted for the cost of capital, of \$110 million from 2022.

Pursuant to D.22-12-031, there are cost of capital adjustments to the Capital Cost Balancing Accounts (SECCBA) of the 2017 PSEP Forecast Application's Safety Enhancement (decrease of \$0.4 million with FF&U, prior to the System Integration), 2016 PSEP Reasonable Review (decrease of \$0.2 million with FF&U, prior to the System Integration) and 2018 PSEP Reasonable Review (decrease of \$1.4 million with FF&U, prior to the System Integration).

<sup>1</sup> Pursuant to D.06-04-033 SoCalGas and SDG&E's transmission systems are considered an integrated system for cost allocation and rate design purposes.

### Adjustment to Revenue Requirement in Accordance with Internal Revenue Service Private Letter Ruling - AL 6018 and D.19-09-051

Pursuant to AL 6018, SoCalGas is adjusting the revenue requirement in compliance with the findings of the Internal Revenue Service (IRS) regarding whether to include or exclude certain costs from the Average Rate Assumption Method (ARAM) calculation, so as to be consistent with the IRS's tax normalization rules. This adjustment is made in accordance with Ordering paragraph (OP) 21 of the Test Year 2019 General Rate Case (GRC) Decision of SoCalGas and San Diego Gas & Electric Company (D.19-09-051). SoCalGas also is consolidating this adjustment with an overcollection related to 2018 income tax savings. The total adjustment with FF&U is an increase of \$56.8 million (with FF&U).

#### Storage Integrity Management Program – AL 6023 and D.22-08-011

Pursuant to D.22-08-011 and AL 5817, the updated revenue requirements for the ongoing capital-related costs for the approved Storage Integrity Management Program (SIMP) capital projects including regulatory account interest is \$35.6 million (with FF&U).

#### On-Bill Financing Change – AL 5853-A

Pursuant to AL 5853-A, SoCalGas requested to modify the loan limits for business customers, align multifamily loan limits between mainstream energy efficiency (EE) and low-income Energy Efficiency programs, and increase the On-Bill Financing loan pool from \$5.5 million to \$10 million. The increase with FF&U is \$4.6 million.

#### Triennial Cost Allocation (TCAP) Implementation – AL 5907 and D.21-07-019

Pursuant to D.21-07-019 and AL 5907, the updated transmission embedded study resulted in an adjustment of \$12.1 million revenue requirement to SoCalGas from SDG&E. SoCalGas and SDG&E's transmission system integration mechanism requires SoCalGas to recover SDG&E's backbone transmission system costs and SDG&E to recover a share of the integrated local transmission system costs.

#### Natural Gas Leak Abatement Program

AL 5950, the request for the recovery of 2023 Natural Gas Leak Abatement Program revenue requirement, has not yet been approved. Approval is expected in the first quarter of 2023. For this filling, SoCalGas kept the 2023 revenue requirement at the same level as the 2022 revenue requirement of \$86.4 million (with FF&U).

#### LCFS Program Annual Credit and Revenue Estimates (2023) - AL 5874

The 2023 natural gas vehicle (NGV) rates reflect the return of credit for the LCFS program, a credit of \$0.42527/therm (with FF&U).

#### Other SoCalGas 2023 Revenue Requirement Adjustments

The 2023 SoCalGas revenue requirement also include the following adjustments to ensure common rates<sup>2</sup> between SoCalGas and SDG&E for certain gas customer classes: an increase of \$4.239 million to ensure common Electric Generation rates, an increase of \$4.459 million to ensure a common NGV rates and an increase of \$8.34 million to ensure common Transmission Level Service (TLS) rates. All 2023 rate changes are submitted to be effective concurrently with SDG&E's 2023 consolidated gas transportation rates.

In addition, SoCalGas' revenue requirement includes adjustments for SoCalGas and SDG&E's transmission system integration mechanism whereby SDG&E pays a share of the integrated local transmission system costs. In addition to the TCAP implementation System Integration adjustment discussed above, additional System Integration adjustments to SoCalGas' 2023 PSEP base margin revenue requirement are; (i) an allocation of \$0.12 million from SoCalGas to SDG&E; and (ii) an allocation of SDG&E's \$10.845 million of PSEP backbone transmission balancing accounts costs to SoCalGas Backbone Transportation service.

Included with this submittal are a combined summary of Natural Gas Transportation Rate Revenues (Attachment B) and a table that summarizes the above-mentioned components of the change in revenue requirement (Attachment C).

Of the total revenues, \$2,737,825,000 is allocated to the core market, \$489,522,000 is allocated to the noncore market, and \$104,151,000 to the Backbone Transportation Service.

#### 2. REGULATORY ACCOUNTS

Included below are the major balancing accounts. For a complete listing of all regulatory accounts, please refer to Preliminary Statement, Parts V, VI, and VII.

SoCalGas is authorized to submit an annual advice letter on October 15 to update SoCalGas' applicable regulatory accounts for recovery in rates. The purpose is to amortize the projected yearend balances or applicable revenue requirements in rates January 1 of the following year. Ordering Paragraph 21 of Decision (D.) 20-02-045, SoCalGas' 2020 TCAP, authorizes this annual advice letter submittal.

This schedule is applicable, in combination with the customer's otherwise applicable rate schedule, to Residential customers.

#### **TERRITORY**

This schedule is applicable within the entire territory served by the Utility.

#### **RATES**

Pursuant to Commission Decision (D.) 15-10-032:

1) Residential Annual California Climate Credit

Eligible residential accounts receive a California (CA) Climate Credit, if applicable, each April 1st. The credit will display on the customer's bill on the next scheduled bill date. Master-metered rate schedules GM and GS receive one credit per sub-unit. Credits are issued to all active accounts receiving natural gas service on the date the credit is given. One credit will be given per household, so accounts with more than one service point receive only one credit. The discount for customers qualifying for California Alternate Rates for Energy (CARE) will be calculated before the CA Climate Credit is applied to ensure no impact to the benefits of the CARE program.

#### SPECIAL CONDITIONS

- 1. <u>Definitions</u>: The definitions of principal terms used in this schedule are found either herein or in Rule No. 1. Definitions.
- 2. <u>General Description</u>. The CA Climate Credit is shown on a customer's bill as a separate line item. The credit is authorized to return to ratepayers the proceeds derived from the Utility's sale of directly allocated Greenhouse Gas (GHG) allowances in compliance with the California Cap on GHG Emissions and Market-Based Compliance mechanisms (Cap-and-Trade Program) regulations imposed by the California Air Resources Board (CARB).
- 3. <u>Filing Requirements</u>. Pursuant to D.15-10-032, the Utility shall include proposed credit rates as part of the annual regulatory account update advice letter filing.
- 4. <u>Master-Metered Customers.</u> Customers receiving service under this schedule shall comply with the provisions of Public Utilities Code 739.5 in providing service to their sub-metered tenants.
