<u>Purpose</u>

In accordance with Resolution E-5200, Ordering Paragraph (OP) 4, SoCalGas hereby submits to the Commission this Tier 1 Advice Letter (AL) to update bill caps within 30 days of the passage of the Resolution, based on the June 1, 2022 updated California Alternate Rates for Energy (CARE) income guidelines.

Background

In Decision (D.) 21-10-012, the Commission authorized the investor-owned utilities (IOUs) to establish PIPP pilot programs, in accordance with certain guidelines. The PIPP pilots set utility bill payment amounts at a percentage of the qualifying participants' monthly income. Monthly bill caps will be standardized for households in two income tiers: 0-100% and 101-200% of Federal Poverty Guidelines. D.21-10-012 required the IOUs to file Tier 3 ALs within 120 days that outlined the PIPP pilot and established associated balancing and memorandum accounts. The IOUs filed ALs on February 4, 2022 to establish their PIPP pilots and associated accounts. The Resolution approved with modifications the PIPP pilots.

The Resolution directs the IOUs to: "(1) file a Tier 1 AL to establish PIPP bill caps within 30 days of the passage of the Resolution and, (2) starting in 2024 and through the duration of the PIPP pilot, bundle the updated PIPP bill caps within the same Tier 1 AL filing that updates the CARE income guidelines around April 30 each year." The Resolution also provides that in "their annual AL filing starting in 2024, the IOUs shall establish PIPP bill caps

with the same effective dates as CARE income guidelines – from June 1 to May 31 of the following year."⁴

Proposed Revisions

In compliance with the Resolution, SoCalGas hereby submits a revision to its Tariff Rule 12 to update the bill caps for PIPP. The revision reflects changes to synchronize the bill caps at 4% with the 2022 CARE program income guidelines. Also, in compliance with Resolution E-5200, these new bill caps will be effective January 30, 2023 until May 31, 2024. The table below shows the new bill caps that will be used for the two income ranges.

- 1. PIPP Eligibility and Enrollment Criteria (Continued)
 - a. Customers that are either located in one of the zip codes with the highest rates of recurring disconnections prior to the disconnections moratorium; or
 - b. That have been disconnected 2 or more times during the 12 months prior to the disconnections moratorium.
 - c. Customers that do not have an Advanced Meter (AM) are excluded from pilot participation. Customers who do not want an AM (AM Opt-Out) may choose to have an AM installed in order to participate in the pilot.

As such PIPP eligibility excludes master-metered operators and its sub-metered tenants, customers who are enrolled in any other pilot, and customers in the CAT customers from the pilot.

2. Rates

Monthly bill caps will be standardized for households in two qualifying income tiers: 0-100% of Federal Poverty Guidelines (FPG) for a household of 3, and 101-200% of FPG for a household of 3. Bill caps will be updated annually to reflect current income guidelines, concurrently with CARE program income guideline updates.

PIPP pilot participants will receive a monthly bill cap their gas charges equal to their qualified income tier.

Effective the approval date of Advice No. 5936, the monthly bills caps for gas is as follows:

Tier 1. 0-100% of FPG \$9.00

Tier 2. 101-200% of FPG \$29.00

The PIPP Pilot bill cap will be applied to a customer's bill prior to calculating any third-party taxes, charges, and fees and will appear as a line-item discount. The line-item discount will be either (a) the difference between the bill cap and the sum of the charges subject to the bill cap, or (b) zero if the sum of the charges is lower than the bill cap.
