Southern California Gas Company (SoCalGas) hereby submits for approval with the California Public Utilities Commission (Commission) update to SoCalGas' tariff schedule, applicable throughout its service territory, as shown in Attachment A.

Purpose

Pursuant to D.23-02-014, Ordering Paragraph (OP) 4, which modifies the schedule of SoCalGas's 2023 California (CA) Climate Credit disbursement, SoCalGas hereby submits to the Commission this advice letter to update Tariff Rate Schedule No. G-CCC, Greenhouse Gas CA Climate Credit, to accelerate disbursement of the 2023 Climate Credit to eligible residential accounts beginning February 3, 2023.

Background

D.23-02-014 ordered each of the utilities to accelerate the disbursement of the April 2023 natural gas and electric climate credits to a date as soon as can be implemented for that utility, which the Commission expects to begin no later than March 1, 2023. The decision clarifies that its acceleration of the April 2023 climate credit applies to those credits only, and that as of May 2023 the normal schedule for climate credit disbursements for residential customers shall resume. This decision also waives climate credit messaging and outreach requirements for the accelerated April 2023 gas and electric climate credit disbursement.

Proposed Update

SoCalGas proposes to incorporate the following special condition, No. 5, to Tariff Rate Schedule No. G-CCC, "Pursuant to D.23-02-014 accelerating disbursement of the 2023

Credit, eligible residential accounts shall begin to receive the 2023 Credit on February 3, 2023." As indicated in D.23-02-014, the normal schedule for natural gas climate credit disbursements for residential customers shall resume as of May 2023.

APPLICABILITY

This schedule is applicable, in combination with the customer's otherwise applicable rate schedule, to Residential customers.

TERRITORY

This schedule is applicable within the entire territory served by the Utility.

RATES

Pursuant to Commission Decision (D.) 15-10-032:

1) Residential Annual California Climate Credit

Eligible residential accounts receive a California (CA) Climate Credit, if applicable, each April 1st. The credit will display on the customer's bill on the next scheduled bill date. Master-metered rate schedules GM and GS receive one credit per sub-unit. Credits are issued to all active accounts receiving natural gas service on the date the credit is given. One credit will be given per household, so accounts with more than one service point receive only one credit. The discount for customers qualifying for California Alternate Rates for Energy (CARE) will be calculated before the CA Climate Credit is applied to ensure no impact to the benefits of the CARE program.

SPECIAL CONDITIONS

- 1. <u>Definitions</u>: The definitions of principal terms used in this schedule are found either herein or in Rule No. 1. Definitions.
- 2. <u>General Description</u>. The CA Climate Credit is shown on a customer's bill as a separate line item. The credit is authorized to return to ratepayers the proceeds derived from the Utility's sale of directly allocated Greenhouse Gas (GHG) allowances in compliance with the California Cap on GHG Emissions and Market-Based Compliance mechanisms (Cap-and-Trade Program) regulations imposed by the California Air Resources Board (CARB).
- 3. <u>Filing Requirements</u>. Pursuant to D.15-10-032, the Utility shall include proposed credit rates as part of the annual regulatory account update advice letter filing.
- 4. <u>Master-Metered Customers.</u> Customers receiving service under this schedule shall comply with the provisions of Public Utilities Code 739.5 in providing service to their sub-metered tenants.
- 5. <u>2023 CA Climate Credit</u>. Pursuant to D.23-02-014 accelerating disbursement of the 2023 Credit, eligible residential accounts shall begin to receive the 2023 Credit on February 3, 2023.
