Subject: Southern California Gas Company's Unspent and Uncommitted Funds for Program Year 2022 in Compliance with Ordering Paragraph 3 of Decision 21-01-004

Purpose

In accordance with Ordering Paragraph (OP) 3 of Decision (D.) 21-01-004, and the extension granted via procedural email from Administrative Law Judges Kao and Fitch, Southern California Gas Company (SoCalGas) hereby submits this Advice Letter (AL) to the California Public Utilities Commission (CPUC or Commission) to detail its 2022 unspent and uncommitted funds for the Assembly Bill (AB) 841 Schools Energy Efficiency Stimulus Program.

Background

Decision (D.) 21-01-004, which established directions to the investor-owned utilities (IOUs), including Pacific Gas and Electric Company, San Diego Gas & Electric Company, Southern California Edison Company and SoCalGas, for funding the School Energy Efficiency Stimulus Program (administered by the California Energy Commission (CEC)), authorized the Utility Audit Branch to conduct an audit of the IOUs' unspent and uncommitted energy efficiency funds for program year (PY) 2020. Unspent and uncommitted energy efficiency (EE) funds for PYs 2020, 2021, and 2022 constitute a portion of the funds to be transferred to the CEC for administration of the School Energy Efficiency Stimulus Program.

Administrative Law Judge (ALJ) Kao, via e-mail ruling on Dec 17, 2021, directed the IOUs to each submit a Tier 2 AL no later than April 1, 2023, to true-up any PY 2022 unspent and uncommitted amounts. The e-mail ruling directed each IOU to disburse to the CEC its applicable unspent and uncommitted funds in a single lump sum after being invoiced by the CEC.

On March 17, 2023, pursuant to Rule 11.6 of the Commission's Rules of Practice and Procedure the IOUs requested an extension for the submittal of a Tier 2 AL to true-up any program year 2022 unspent and uncommitted amounts, as required by ALJ Kao's "R.13-11-005 Email Ruling Providing Notice and Opportunity Re: Audit of Unspent and Uncommitted Funds" dated December 17, 2021 (ALJ Email Ruling). Specifically, the IOUs requested an extension to April 17, 2023 to file the Tier 2 AL to specify the amount of PY 2022 unspent and uncommitted funds that each IOU proposes to transfer to the CEC. On March 20, 2023, on behalf of behalf of ALJs Fitch and Kao, ALJ Kao granted the request via procedural email and SCE notified the service list of R.13-11-005 of the procedural response granting the extension to April 17, 2023.

Discussion

Pursuant to ALJ Kao's e-mail ruling on December 17, 2021, and pursuant to OP 3 of D.21-01-004, SoCalGas respectfully submits the EE PY 2022 unspent and uncommitted funds (Table 1) to be disbursed to the CEC for administration of the School Energy Efficiency Stimulus Program. The PY 2022 unspent and uncommitted funds amount to \$408,405.
